Subject: Eastern Band of Cherokee Indians (EBCI) 401 Certification of Nationwide

The Eastern Band of Cherokee Indians, 401 Water Quality Certification, has reviewed the U.S. Army Corps of Engineers Final 2017 Regional Conditions for Nationwide Permits (NWPs) in the Wilmington District.

401 Water Quality Certifications are hereby approved for all NWPs on federal lands held in trust for the Eastern Band of Cherokee Indians.

The EBCI 401 Water Quality Certification for the proposed NWPs is contingent upon the following items being included as regional conditions to any NWP's issued:

March 2nd, 2017

(1) Scientific Measurement Devices (NWP-5). "Scientific Measurement Devices may not be located on Tribal lands or waters without prior written approval from the EBCI"

(2) Survey Activities (NWP-6). "Geological exploratory devices or exploratory activities may not be located on Tribal lands or waters without prior written approval of the EBCI. Additionally, the use of ground penetrating radar or isotope technology are not authorized on Tribal lands or waters without the prior written approval of the EBCI"

Provided the two items listed above are included in the Regional Conditions, this letter certifies that the above described NWPs will comply with the applicable provisions of the federal Clean Water Act and the EBCI's Water Quality Standards.
